The conditions under which Registration is issued are:-

1. Application for granting further continuance of registration should be submitted to this office three months in advance before the expiry of the temporary registration already granted.
2. The Management should not appoint any staff whose Certificate has been cancelled or who has been convicted for offence involving moral turpitude.
3. The State Government grant will not be given at present.
4. Qualified teachers should be appointed in 1: 8 ratio.
5. The building license should be renewed after the expiry of the date.
6. The institution should provide reasonable representation to persons with disabilities in the decision making structures as per Section 66(3).
7. The Management should employ not less than 3% for persons or class of persons with disability as per section 33 of Chapter-VI of the PWD Act, 1995.
8. Rain Water Harvesting facilities should be made in the Institute immediately.
9. This certificate should be displayed prominently for the information of parents / general public in the office room.
10. The following words may be mentioned in the name board of the Institute –
AMAR SEVA SANGAM, , 7-4-104 B, Tenkasi road, Ayikudy post, Tenkasi taluk, Sulochana Garden, Tirunelveli 627852(for CBR Programme and

Training Programme) is registered under Section 52 of Persons with Disabilities Act, 1995, temporarily for a period from 1.6.2012 to 31.5.2015.

11. Institution should follow rules/regulations issued by State Commissioner for the Disabled from time to time.
