May I also hope that Ramakrishnan and Sankara Raman will go on and on undaunted with the good and noble task of inspiring us with their own dedication and selfless service!

MISSION

The Sangam's ultimate aim is to empower the disabled and it is a process that will start from different entry level rehabilitation plans, depending upon their age, socio economic background and the nature and extent of disability. They are

discharged from direct rehabilitation intervention to integrate them with society and their families. Amar Seva Sangam believes that this area can become a valley of the disabled where, everyone is considered as human being and the disability is only a part of human diversity in nature's creation. Equality should prevail and humanity is the ultimate winner.

QUALITY POLICY

Amar Seva Sangam is committed to satisfy physically challenged service users by empowering them to have an equal participation in the society. This is achieved by providing them appropriate rehabilitation services of excellent Quality and continuously improving the same.

Management Report

Amar Seva Sangam (ASSA) has successfully completed 39 years of distinguished service for the cause of the differently abled by providing shelter, medical help, vocational training, new avenues of employment and rehabilitation, more particularly Early Intervention in children with developmental delays, besides supplying necessary mobility appliances.

Started in 1981 in a humble way with a few students, the Sangam had flourished and reached new heights. Today, Amar Seva Sangam is a much sought-after premier institution in the field of Disability Management in the country. This was and is possible only because of the support and patronage of well-wishers who stood by our side during times of crises. We are all indebted to them for their support.

Effective cost control measures, strict surveillance and constant monitoring have resulted in producing much better results. More efforts will have to be put into all the departments to ensure continued improvement in the financial performance for continued and sustained development. This is definitely not an easy task in view of ever-increasing inflation in all fields of the Sangam's activities. In 1981, when physical disability was not an important aspect to be considered for empowering people, the Sangam was started in a very small area and with a very small means. However, over the years, to our surprise the Sangam had grown to this level with multifarious activities for the development of persons with disabilities. This was possible only because our donors big and small had faith in us and in our work. In 1990, with the introduction of new initiatives exclusively for the development of the disabled persons, our main goals then were to help the differently abled, give them medical assistance, provide them good education, help the rural poor, orphans and aged besides promoting family/women's welfare. Subsequently these initiatives led us to gradually increase our areas of activities keeping in mind the ever-changing scenario in the medical field. During the last few years, we have further widened our scope, both in vocational training and medical facilities, by starting a new Tailoring Unit, an Early Intervention Center an Institute of Rehabilitation Sciences and establishing an ITI center to promote skill development among students with disabilities in various trades.

Flagship Program – Scale up of m-El for Home-based Early Intervention of Children with Developmental Delays:

What started as a pilot project in 2015, has scaled up to cover 2000+ children who are rehabilitated at home using innovative technology-based m-EI App where community workers reach out to children at their door steps for rehabilitation. This program has given significant outcomes with evidence impact of increase in school enrolment from 57% to 85% besides reducing stress of caregivers/ parents up to 74%. This program has rehabilitated more than 2600 children after screening more than 55,000 children. This program is actively supported by Grand Challenges Canada (a unit of Canada Govt.), Handi Care Intl, Canada, Azim Premji Philanthropic Initiatives and Tamil Nadu State Government. This flagship program won many awards for innovation from MIT-Solve, Vodafone, Zero Project Award, Project Management Institute Award, The Spindle, World Cerebral Palsy Day Award, NIPMAN Foundations. Based on the success of the Early Intervention program, Amar Seva Sangam felt a compelling need to organize an International Conference on Early Intervention of Children with Developmental Delays which was held at Chennai from February 13th to 15th. The conference was well attended by 55 delegates from overseas countries and 400 Indian delegates with multiple sessions of workshop, poster presentation, technical presentations by experts and speeches by eminent personalities on child development. The conference was inaugurated by His Excellency, Shri Banwarilal Purohit, Governor of Tamil Nadu.



Inauguration of Amar Seva Saradambal ITI:

With an aim to promote skill development programs for **Persons with Disabilities and Women** to achieve the high level quality in skill training with National Standards, with valuable accreditation, to ensure continuity in education and possible employment thereof, Amar Seva Sangam inaugurated **Amar Seva Saradambal ITI** on 08.10.2019, approved after due diligence and compliance by the National Skill Development Corporation (NSDC) and Ministry of Skill Development and Entrepreneurship (MSDE). The ITI imparts 6 months to one year skill development programs on Smart phone technician cum App Tester, Cutting and Sewing, Computer Operator and Programming Assistant – COPA (IT &ITES) and Desktop Publishing Operator (IT &ITES) – DTP.

The ITI was inaugurated by Mr. K.A.M Muhammed Abubacker MLA on 08.10.2019.

During 2019-20, 24 students were admitted into the ITI to pursue the skill trainings. The students got a stipend for their training from National Skill Development Corporation.



After successful completion of these programs, students will receive National Level Skill Training Certificates which will help them to get suitable Employment / start Entrepreneurship of their own.

The impact of the organization's activities is far and wide. We have raised our performance to a level to prove at large that disability is not a constraint but only a condition that is to be understood and lived with. The total number of services received by persons with disabilities who have got direct rehabilitation since the inception of Amar Seva Sangam is 60418.

The social impact of our rehabilitation and training program had resulted in growth of number of persons benefitted by our services. We have discharged 979 people as on March 31, 2020, after rehabilitation and they are at their respective places. Brief details are as under:

Amar Seva Sangam was founded in Ayikudy in 1981 - the International Year for the Disabled, by Shri S. Ramakrishnan with only a few students. His ambition was to become a Naval Officer. He cleared many of the physical fitness tests during SSB at Bangalore; but unfortunately, in the last round of the test held on 10th January 1975, he fell down and broke his spine. He became a quadriplegic and after intense treatment both at Bangalore and Pune (in Defence Hospitals), he returned to Ayikudy. He decided to start a school for the Rehabilitation of the children with disabilities. He christened the Organization as Amar Seva Sangam as a respect to his Doctor/mentor Amarjit Singh Chahal. Bharat Ratna Late Shri C. Subramaniam was the first Chief Patron and Dr. M.S. Swaminathan is the current Patron-in-Chief, while Shri N. Vaghul, Former Chairman of ICICI is the present patron. What was started as a small school with few children has grown over the years and after thirty-nine years today, Amar Seva Sangam is a premier institution in the field of disability management in the country. The school which had only handful of children to start with in 1981 has now grown up as a good Higher Secondary School guided and taught by dedicated teachers. The Nursery School also has a good strength of boys and girls - with dedicated teachers and Helpers. Smt. Sivasankari, the famous Tamil writer and Novelist, who made known almost to the whole world the good work done by Shri S. Ramakrishnan and her write-up in the famous and very widely circulated Tamil Weekly Magazine 'Ananda Vikatan' touched the hearts of millions of people in India and abroad who generously contributed in cash and kind to the growth of the organization appreciating the undaunted spirit of the disabled person, Shri Ramakrishnan in wheel chair, who is working for the cause of not only the children with disabilities but also for the downtrodden as a whole.

In 1992, **Shri S. Sankara Raman**, a practicing Chartered Accountant at Chennai and wheelchair user, due to Muscular Dystrophy, relinquished his lucrative practice and joined

Today, we have a Home for the Disabled Children, a school for Special Children, an inclusive and integrated Higher Secondary School for both the students with disabilities and other students, a Medical Evaluation Unit for the persons with disabilities, a center for Spinal Cord Injured persons, a centre for Early intervention for children with developmental delays, separate hostels for boys and girls, Vocational Training Center for making Note Books, a Typing Center, a Tailoring Center, Handicrafts making center and an Advanced Computer Training Center and ITI Center. ASSA believes that mere rehabilitation without proper education is empty. Hence, we stress importance for formal education and it is in this context that we have opened a Special Study Center of Indira Gandhi National Open University (IGNOU) and also of Alagappa University in the campus.

All these were possible only because of the support of kind-hearted people like you and support of the corporate. With your continued support we are confident of realizing our dream of establishing "The Valley for the Disabled" as a Rehabilitation and Development Center for the region and developing models for self-help initiatives by integrating the disabled individuals with the society for improved living conditions in the village.

We have successfully conducted an international conference on Early Intervention for children with developmental delays which evoked great response and potentials for building up partnerships for scale up of our program.



1. Institution Based Rehabilitation

1.1. REHABILITATION

1.1.1. Home

The Home provides Free Shelter, Food, Clothing, Transportation, Medical Aid & Appliances and Education in the Sangam's Play/Nursery/Primary/Higher Secondary Schools to Children who are in the age group of Five to Eighteen. Higher Education is provided outside the Campus. They are also given Special Coaching.

S. Anandhi, D/o. Mr. Shankar, (aged 16 years) is affected by Cerebral Palsy (CP), was admitted in the Home of Amar Seva Sangam in the year 2009. She started her education from LKG at Siva Saraswathi Vidyalaya School and at present she is studying 10th Standard. Through corrective surgery her leg was operated at Madurai Hospital, subsequently physiotherapy was given to her. With the help of walker and crutches now she is able to walk independently without any one support. She is very good in her studies, sings well, won many chess tournaments at District / State level.



V. Esakkiraj, S/o. Mr. Vadivel, (aged 17 years) due to Cerebral palsy (CP), came to ASSA through a well-wisher during the year 2014. He started his education from 6th at Siva Saraswathi Vidyalaya School and at present he is studying 10th standard. He is very good in his studies and won many Chess Tournaments at District / State level.



1.1.2. Sangamam School for Special Children

SANGAMAM School for Special Children is a Day Care Center which was started in 1997 with only nine children. Handi-Care Intl, Canada - one of our major donors, raised funds for the construction of the building and a full-fledged school was inaugurated in 2008. Special children who need individual and particular care residing at various places in and around Ayikudy are brought to the School by Sangam's vehicles sponsored by ASHA for Education, Seattle USA – (Berkley Chapter). While at Special School, they are trained in daily living activities, life skills, self-care, reading. writing and speech apart from vocational skills. Besides physiotherapy and additional health care requirements, the children are also provided with free nutritious lunch, biscuits and milk.



Children with developmental disabilities would include children requiring an array of different interventions. This helps them to get needed services by setting appropriate goals, and therapy plans.

MASTER OF THE YEAR:

K. Mohammed Usman, 13 years old boy has Intellectual Disability and Speech Impairment. When he was admitted in Sangamam School in the year of 2018, he was never speaking to anyone and had poor attention and unable to complete any task.

Now he has been taught Special Education in Secondary Class. He also takes Occupational Therapy, Speech Therapy, Music Therapy and Play Therapy. Now he is able to do every task with attention. He can do ADLs (Activities of Daily Living) independently. His Speech level is developed to sentence level and his socialization skills are improved. He can play Indoor and Outdoor Games with peers. He mingles with all teachers and communicates with others. His writing and Domestic Skills are also improved. He helps his friends whenever they need. This year he attended the District Level Sports meet in Tirunelveli and Cultural competition in Chennai.

1.1.3 Orthotics Center

The Orthotics Section was established in 1993 which is functioning inside the campus manufacturing, repairing and servicing calipers and other appliances both for the residents of the Sangam and for people in the villages. The entire Services are provided at Free of Cost. Initially, we had assembling and repair correction facility based on the minimum requirement. Year after year the requirements of appliances and repair correction increased by the extension of the service areas in our Village & Institution-based Rehabilitation Services through awareness.

We started assembling different types of appliances including assembling of wheelchair & Repair correction based on the Service User's Disabilities with help of Indian & Foreign Physiotherapists and Occupational Therapists and year by year wise steadily increased the numbers of assembling appliances and repair corrections.

Ms.Eshika aged 9 years D/o.Mr.Murugan residing at Kadayam is affected with Scoliosis. Her father works for daily wages as coolie and mother is a homemaker. Her mother used to do all the ADL activities for her daughter Eshika. Through a well wisher they came to Amar Seva Sangam for assessment and after examining her she was advised for Appliance named 'Body Brace'. Considering her family economic condition ASSA offered the appliance free of cost. At present, she is able to do her activities independently with a little bit of support from her parents. Her family thanked Amar Seva Sangam.



1.1.4. Medical Testing Unit (MTU)

The Medical Evaluation Unit, also known as Medical Testing Unit (MTU) was set up in 1998 with the support of Government of Japan. As a nerve center, MTU is extensively used by the families of the challenged individuals. This unit is quite popular and we have a separate section for newborn babies who may need Physiotherapy



attention right from the early stages. The center's approach is modern and uses items like soft mattresses, mirrors, specific play materials for the children apart from new rehabilitation techniques. All these facilities are extended to the users at a very nominal cost.

Apart from treating patients, many physiotherapy students from various colleges in Tamil Nadu and from Foreign Universities are placed in this unit for Rehabilitation Training as part of their Academic Schedule.

MTU conducts awareness training for the Parents and Caretakers of Children with Cerebral Palsy. It also conducts awareness training for the Medical and Non-Medical people about the Disability.

Daily about 130 service users get benefit from this unit. The unit has well equipped Electro Therapy Appliances which contains various advanced features for treating pain conditions of the Back, Neck, Knee etc. We deliver Special care for the people who have had a Stroke (one half of the body paralyzed) through new Neuro Handling Approaches.

We arrange Corrective Surgery for the needy service users with the Philanthropic Support of Dr.K.Murugiah, who has a well-equipped Hospital in Surandai which is a nearby town and the Philanthropic Surgery done by Dr.Arivasan, an Ortho Surgeon in Madurai and Dr.Aram, a Plastic Surgeon in Madurai. No words of thanks will be adequate to express our gratitude to these doctors.

Master Poosaidurai, 18 years Old Boy is a case of Spastic Cerebral Palsy whose legs are Spastic and unable to stand upright and walk with raised heels and this was the main reason for his frequent falls and unsteady walking pattern.

After Surgical Release of his tight heel cord on both legs and followed by Intensive Physiotherapy in the form of strengthening exercises and Gait Training, now he is able to stand erect and walk independently and climb stairs with minimal support.





Master Muthukumar, 15 years Old Boy is a case of Cerebral Palsy, presented with tightness of both leg and severe scissoring of legs during walking. He used walker for outdoor mobility and was unable to go up and down stairs, stand and walk independently.

After Surgical Release of his tight back and inner thigh muscles and followed by Intensive Physiotherapy in the form of strengthening exercises and gait training, now he is able to stand without support for few minutes and walk few steps without any aid. He uses bilateral elbow sticks for outdoor mobility and climbs stairs up and down.





1.1.5 Spinal Cord Injured Post-Acute Care Center

The Spinal Cord Injured Post-Acute Care Center was started in 2007. The patients are from all over India and so far, 153 service users were rehabilitated and discharged and out of these 132 are actively engaged in pursuing their livelihood. The Center has become very popular and we have a long waiting list of nearly 87 spinal injured people from different parts of India for admission in the center.

This unit provides Service Users both with Medical and Vocational Rehabilitation. It mainly focuses on developing independent daily living skills.

It provides good nursing care, manages complication and gives suitable vocational training and psychological counseling to meet the challenges which one may have to face during the rest of their life.

We conduct annually get -together programs of the Discharged Spinal Injured Patients living in various places for them to interact. These programs include Free Medical Camp, follow up visits and Vocational Counselling. This center keeps in touch with all Discharged Patients by regular house visits.

We also advise the Service Users, as regards changes required in their house structure so that it becomes user friendly for them.

The Successful Trainees

M. Pratap, S/o Mr. Murugaiah, aged 20 years residing at Avudaiyapuram, Sankarankoil Taluk came to Amar Seva Sangam through a well wisher during 2017. He has completed 9th standard and could not study further due to his family economic conditions. He was affected with Cerebral Palsy (CP). Through Physiotherapy Treatment at ASSA there was a good improvement in his walking aspects. Through Vocational Training at ASSA he completed Two Wheeler Mechanism courses, MS Office, Handwork and Junior Level Typewriting. He was provided with a set of Calipers to make his movement even easier. At present he is working in a Petrol Bunk at Sankarankoil earning a monthly Income of Rs.4500/-.



N.Raghavan, S/o.Mr.Narayanan, aged 27 years residing at Mylapore, Chennai came to Amar Seva Sangam (ASSA) through a well wisher during 2018. He was affected with Mental Retardation (MR) and could not continue his studies after 5th standard. He was admitted in our Sangamam Special School Vocational Training Center. They taught him the fundamentals of computers, preparation of chalk piece and activities for improving his life skills. At present he is working as a Data Entry Operator in a telecommunication unit at Chennai earning a monthly Salary of Rs.5000/-. His parents were very happy and they thanked ASSA which made a change in their son's life.



1.1.7 Rehabilitation Center (RHC)

The Rehabilitation Centre within the campus provides number of support services like Scholarship, Free Bus/ Train Passes, Vocational training, Artificial limbs, School Fees, Notebooks, Wheelchairs, Job Placements and other services to needy Physically Challenged Children and Adults. The scope of services covers four districts of southern Tamil Nadu viz., Tenkasi, Tirunelveli, Thoothukudi and Virudunagar. The objective behind this is to reach out to people with Direct Delivery of Services where Village Based Rehabilitation Services have not reached yet. The total number of Service Users during the year was 10405. Under the Guidance of the Institution Based Rehabilitation Activities Various Community Support Services were offered as mentioned below:

1.2. Vocational Training

Amar Seva Sangam, apart from rehabilitation activities also provides Vocational Training in Tailoring, Handicrafts, toy making, note-book making and book binding, Typewriting and Advanced Computer Training for the Youth Trainees with Disabilities. Many trained youths have been selected by leading software and other manufacturing organizations and are getting good salaries.



1.2.1. Tailoring / Handicrafts/ Notebook making and Binding

The Tailoring section was started in 1999 with only four physically challenged students. Till 2006 this section was only a tailoring training center .

The handicraft center makes toys, artificial jewellery, painting on fabrics, ceramics, sarees, glasses, stoneware and other items. The center is always upgrading its quality and bringing out innovative designs which are always in good demand.

This center prepares all the mementos that the Sangam presents to various visitors besides meeting orders of the visitors who are impressed by our work. It may be mentioned here that staff well versed in handicrafts are very few in number. We intend taking aggressive marketing steps to boost up our sales of handicrafts/ toys.

1.2.2. Typewriting Center

Typewriting center provides training to rural poor and physically challenged students to get employable skills. The Tamil Nadu Government conducts the examinations twice a year. The Government of Tamil Nadu had made it obligatory that passing the senior grade typing examination is necessary for data entry jobs both in Government and private sectors. Due to this Government regulation, many data entry aspirants nowadays join the senior grade typing classes. It has been observed that the students approaching the typing center are keen to learn typing both in English and Tamil.

1.2.4. Amar Seva Saradambal ITI

With an aim to promote skill development programs for **Persons with Disabilities and Women** to achieve the high level quality in skill training with National Standards, with valuable accreditation, to ensure continuity in education and possible employment thereof, Amar Seva Sangam inaugurated **Amar Seva Saradambal ITI** on 08.10.2019, approved after due diligence and compliance by the National Skill Development Corporation (NSDC) and Ministry of Skill Development and Entrepreneurship (MSDE). The ITI imparts 6 months to one year skill development program on Smart phone technician cum App Tester, Cutting and Sewing, Computer Operator and Programming Assistant – COPA (IT &ITES) and Desktop Publishing Operator (IT &ITES) – DTP.

The ITI was inaugurated by Mr. K.A.M Muhammed Abubacker MLA on 08.10.2019. During 2019-20 24 students admitted into the ITI to pursue the skill trainings. The students got a stipend for their training from the National Skill Development Corporation.

1.3. Education

Education empowers people and makes them to lead quality life and many of the rural children in and around ASSA were made to get the benefit of education by our initiative of starting schools in our premises. Unlike the urban schools, the normal children pay a nominal annual school fees while it is free education for the students with disabilities. The integration of these children in our school helps them to understand each other's needs in a better way.

1.3.1. Nursery, Primary and Higher Sec. Schools

The nursery school setup in 1981 and upgraded to middle school in 1991 was elevated to the status of a high school in 2009 and the eighth batch of 10th standard students appeared for the public SSLC examination in March 2020. We are pleased to record results of cent percent success, with the first, second and third rank students obtaining marks 458/500, 428/500 and 377/500 respectively. We are proud to mention that our Home student, S.Kavitha, a student with disabilities had scored 341/500 and our Home student R.Mohanakrishnan, who is also a student with disabilities had scored 268/500.

The third batch of 12th Standard students secured cent percent success in their exams during March 2020. The first three toppers scored 565/600, 502/600 and 489/600 respectively. The results of SSLC and Plus Two are very encouraging to all, especially a recognition to the hard work put in by both Teachers and the students.



- Siva Saraswathi Vidyalaya School has spacious and well ventilated classrooms; playground, computer lab and library. The existing Play school is very much enjoyed by Nursery students. Our children are encouraged to play sports like cricket, football, khokho, volleyball, throw ball, kabadi, etc. which help them to be fit & healthy. We provide quality education with qualified teachers. Primary school teachers underwent many trainings like Shraddha, Katha on Ratha, etc. We have a good library with many books for the school students to gain knowledge. Students can use books from library for reference to score more marks in public examination. Our Students have capacity to select their subjects for pursuing their higher studies. Inclusion in education brings all students together in one classroom regardless of their psychological & physical strengths. Qualified teachers are appointed for teaching children with special needs, who have scored good marks in X standard and school final examinations conducted by the Education Department of the Tamil Nadu Government. Our students participate in other extracurricular activities like Yoga, karate, meditation, bharathanatyam and school band. Every year we are getting district level prizes in sports. Some of our students are also participating in national level yoga & chess competitions. P.Surva studying IV std got II prize in south National level yoga competition held at Madurai. S. Indhumathi, P. Sivakavya and J. Mahalakshmi got first prizes in district level guiz competition conducted by District Science Center, Tirunelveli.
- Our students also participate in Scout & Guide activities and won "Rajya Puraskar" award from Governor of Tamil Nadu right from the year 2014. Our student C.Induja received 2018 "Rajya Puraskar" award from our Hon. Governor Mr. Banwarilal Purohit. We also have club activities like Eco club, scout, etc. Our students take active participation in various competitions organized by other schools and win many prizes.

He is a differently able person due to Polio attack. He passed successfully and completed the course in 2019. Now he is working as a Computer Teacher in Siva Saraswathi Vidhyalaya Hr.Sec .School, Ayikudy and earning Rs.12,000/-per month.

1.3.5.3. Amar Institute of Rehabilitation Science:

On identifying the needs for Rehabilitation programs, ASSA had established Amar Institute of Rehabilitation Science, with due approval from Rehabilitation Council of India, New Delhi, under the aegis of which, we are conducting the following Courses on rehabilitation from September 2012 aimed at developing skilled personnel to work at the community level. After completing the courses, young men and women can start rehabilitation services, especially in the rural, tribal areas and also in urban impoverished areas. Furthermore, this service oriented theoretical and practical courses will provide career opportunities to the needy persons. We have got approval from RCI for running the following 2 Diploma courses

- 1. DECSE (MR) Diploma in Early Childhood Special Education (MR)
- 2. CCCG Certificate Course in Care Giving

As the Diploma and certificate courses are conducted in the Amar Institute of Rehabilitation Science, it will be much useful to the persons working in various sections in our Amar Seva Sangam. The following employees of Amar Seva Sangam working in various block have completed the course in 2018-19.

About six students who have completed the course have been absorbed by Amar Seva Sangam and working under project of Early Intervention for the Children with Developmental Delays.

We also conduct vocational training with a view to empower our residents and other differently able persons from in and around areas of Amar Seva Sangam, making them independent and enabling them to be self-employed.

Due to lack of interest in local area to take up the training there was no admission during the year. This skill development program is temporarily suspended.

2. Village Based Rehabilitation Initiatives (VBRI)

2.1 Early Intervention Program - Rehabilitation

Enabling Access in India's Rural Communities

In 2014, we started providing Early Intervention (EI) services to Children with developmental Delays (CwDDs) in rural India by hiring and training local women as Community Rehabilitation Workers (CRWs) to provide EI services to families with CwDDs **in their own homes**. A mobile app (mVBR-EI) was developed to connect CRWs and parents with rehab professionals so that high quality EI services can be provided to CwDD and outcomes can be monitored. The app is also used to screen pre-school children for developmental delays and to set family-centered goals, individual EI therapy plans and weekly support visits.

Our innovation is technology leveraged change shifting the ownership to the parents and providing win win opportunities to the community and the family.

We have reached 1369 CwDD and their families and have screened 55,729 children for delayed development and reached 43,056 people in the community through awareness programs.




Our results have shown 87% visit attendance, leading to improved child development. 73% of families have shown greater empowerment and 74% have shown decreased strain using validated tools and there has been an age-adjusted increase in school enrolment for CwDD from 70% to 85%.


Children reached and impact:

Starting from the pilot phase from 2014 with 50 children, Early Intervention program has reached in scale up to reach more than 500 children. The graph showing the progressive growth of this given below:


Physiotherapy progression report 2016 – 2020

The major health impacts are improved development for children with delayed development. In total, 762 children age 3 and above were able to achieve school enrollment, with an age adjusted (for only those age 3 and above) school enrollment increasing from 70% at the beginning of the program to 85% at 2.5 years into the program.

The major social impacts include improving outcomes for caregivers of children with delayed development, identifying children in the community for delayed development, increasing awareness in the community and training government health workers and child development workers / preschool teachers (Anganwadi workers).

Caregivers Strain Index: Total 1865 caregivers were directly impacted from the intervention. The overall mean change in score for the Family Empowerment Scale was 4.1 representing improved empowerment and the mean change for the Modified Caregiver Strain Index score was -3.7 representing reduced caregiver strain.

Children reached: In total, 55,729 children (28,606 boys) and 27,123 (girls) were screened in case identification camps conducted by ASSA or through direct referrals and 1136 were identified as having a delayed development and 1050 had the opportunity to be enrolled in the program, with the remaining on current wait lists.

In total, 1048 children were provided with medical consultations, 512 were provided with medications, 98 children were referred for surgery and 79 children were provided with assisted devices because of surgical and medical camps conducted by ASSA.



Awareness programs: In total, 17,388 students and teachers attended school awareness programs focused on improving integration for children with disabilities into schools and reducing stigma. They have shown an improvement in knowledge from 2.38 to 4.50 in pre and post-test scoring. In total, 12,088 women attended women's awareness programs focused on how to promote healthy pregnancy and childbirth, how to access prenatal and child health services, understanding child development, childhood disability and early intervention therapy. They showed an improvement in knowledge from 2.17 to 4.4 in pre and post-test scoring.

13,580 community members attended community awareness programs focused on reducing stigma associated with child disability, improving integration of children with disability, how to access health and rehabilitation services and understanding early intervention therapy. They showed an improvement in knowledge from 2.04 to 4.39 in pre and post test scoring.

558 Nurses and 2854 Anganwadi workers were trained in how to identify children with delayed development. In addition, Anganwadi worker training focused on how to improve enrollment and integration of children with delayed development / disability into Anganwadi centers (pre-schools).

PRELIMINARY RESEARCH REPORT:

ASSA is collaborating with University of Toronto's International Center for Disability and Rehabilitation (U of T's ICDR) to help analyze the data in a longitudinal cohort study to assess the children's developmental outcomes. The final analysis has been conducted from the evaluation periods - July 2017, March2020 in collaboration with U of T's ICDR. The analysis shows that those with increased program exposure have better child developmental and caregiver outcomes when compared to those with less program exposure. Outcomes measured included school enrolment, caregiver change, occupational function including (wee-FIM), cognitive (FACP), speech (FACP) and gross motor (GMFM).

PARENT EMPOWERMENT AND KNOWLEDGE TRANSITION PROGRAM:





The program's fifth "Parent Empowerment and consultation workshop" was conducted on June 23, 2019. This program generated positive energy among the parents of differently-abled children in our program. There were 389 parents and 285 early intervention children who participated. The program consisted of experience



sharing sessions, parent training, individual and group psychological counselling for parents. Children in the El program performed dances and plays. In total, 28% of children in the program's fathers participated in the parent empowerment program along with their child and other family members. This was an increase from 10% in previous program. Though increasing father's participation wasn't a direct agenda of our program, it has evolved naturally as fathers have seen their childs' improvement through early intervention therapy and have wanted to get more involved and this will lead to improved father child interaction.

WORKSHOP & CONFERENCE

 "GOT TO SCIENCE WORKSHOP", AT BOSTON, USA

As a mentorship from MIT Solve award, Research Coordinator Dr. Dinesh Krishna and Government Liaison Dr. Aravind Bharathwaj attended a series of Webinar and workshop named *Got to Science* workshop. Massachusetts Institute of Technology and Harvard University, Cambridge Boston, USA jointly conducted this event-as a part of the program Dr. Dinesh and Dr. Aravind attended 3 days in-person



workshop in Boston in January 2020. This workshop consists of various activities including Theory of Change for the project evaluation. This in person workshop occurred in MIT campus, Boston. In day 3 they 2 attended Learn Launch Across the Boundaries conference held in Boston. This conference is about the latest trends in technology access, which can be used in various child development strategies.

2. The Saving Brains Transition to Scale Innovator Workshop was attended by our team in Dubai from April 9-11, 2019. The core purpose of the workshop was to advance individual and collective learning around sustainable scaling of Early Childhood Development work. Dr. Sankar Sahayaraj and Dr. Aravind represented Amar Seva Sangam at this workshop. Each participating innovator presented their scaling process, plans and challenges to colleagues and faculty members at the workshop, with an opportunity for an



in-depth reflection and discussion on strategies and tactics. The workshop was very helpful in formulating our scale up strategies. We used many of the key learnings to help us during scale up work with the government and planning for replication and scaling up with other NGOs.

3. The workshop "Data for Action was attended by Rajeshwaran Senthilnathan (Finance Officer) and Paramakalyani Thangavel (IT Administrator) from Oct 24-29 2019 in Dubai. They found this a very valuable and useful learning experience. In particular, the workshop help our team in identifying and analyzing key indicators and generating dashboards for better monitoring and controls. It helped us to make strategic decisions for the effective and efficient implementation of the program.





INTERNATIONAL CONFERENCE (EIIC 2020)

Amar Seva Sangam conducted an international conference and two pre-conference workshops to introduce our Early Intervention model with the theme: "Early Intervention: Maximizing the Special Need Child's Potential Towards Inclusion".

The main objective of conducting conference was

- To disseminate the knowledge and the exper ience gained by ASSA and mutual sharing of the knowledge and a platform for Global Scale up of the ASSA model.
- To network and collaborate with researchers, program implementers, policy makers and practitioners across the world working in the field of childhood early intervention.
- In total, 642 participants attended the international conference from 30 different states in India, Indonesia, Cambodia, USA, Canada, Bangladesh, Australia and



UK. This included 83 special invitees from Government of Tamil Nadu and India and international and national funding organization leads. There were 18 plenary presentations from renowned faculty around the world.

Pre conference workshop: Training of our program model and dissemination of our research work was provided for 147 health workers including physiotherapists, occupational therapists, special educators, speech therapists, developmental therapists early interventionists, nurses, developmental pediatricians, pediatricians and physicians as part of 2 training workshops that we organized during the International Early Intervention Conference.

Findings of the conference:

- 1. Family centric services: Early intervention is not just for the child; but to the families. Parental stress has the high impact on the outcome of the children. So the Early Intervention program should have the component/ support system for emotional and financial wellbeing of the families.
- 2. Parents as co trainers and advisors: Parents are experts in their child's interests, likes and dislikes; experts of the context, If we take this expertise into our team, the intervention would be more effective and they can spot the opportunities. Let's talk to parents as equals and not in an instructive manner.



- 3. ICF Frame Work: International Classification of Functioning, health and disability Frame work. This shifts the focus from the individual's limitations to participation by considering the environmental and personal factors. The goal of all the intervention in to live the life fullest possible and how do we promote participation. The F words of childhood disabilities are Function, Friends, Fun, Family and the Future.
- 4. Promote cultural change towards equity: The medical professionals working with biomedical aspects and the rehab professionals working with psychosocial aspects of development. Micro nutrients have improved physical development but the cognitive development depends on the social and environmental factors. Promote cultural changes towards equity, respect human diversity and promote inclusion.
- 5. When to start the early intervention: to start as early as neonatal unit when we find some of the early signs of brain damage. Since we work with psychosocial aspects of development, intervention at any time is better.
- 6. Measurement for Change Methodology: Use standard assessment scale that guides intervention and bring change; also measure the impact of the change that is created in child's life and families. The research work we do is not just to prove what works; this should bring change in the quality of our program and continuously evolve the program.



- 7. Sensitization of public about developmental delay and disabilities: Parents can notice and understand the symptoms of certain disabilities. But there is lack of awareness among the parents in identifying the condition like autism, attention deficit hyperactive disorder which delays early intervention. So raising awareness among the public on different delays and disabilities would help the children to get services at the earliest.
- 8. Rehabilitation coverage in health insurance: We need to think of ways and give emphasis to include the rehabilitation into the national health mission; also the cost of rehabilitation should be covered into Ayushman Bharath health scheme.
- 9. Sustainability of the program: Every organization would like to get maximum return for the resources invested and this expectation is more in developmental sector. So engage in small research project that would have impact as well as sustainability with government or community participation.
- 10. Passion and professionalism: Passion and professionalism is must in bringing the right result into the project. Efficiency and effectiveness of the program would come from the professionalism.
- 11. Robust monitoring and evaluation system: should be very essential in any program particularly to showcase the effectiveness of the program. Technology support in identifying and monitoring the progress of the children, monitoring the project has been explained by many experts. ASSA's mvBRI was evolved keeping in mind the three barriers. 1. Remote communities. 2. Cost 3. Lack of Rehab Professionals.

2.2 Village Based Rehabilitation – Above 6 years:

This is a community based rehabilitation program for children in the school age from 6 to 18 years. The objective of this program is to improve functional capacities of Children with disabilities and facilitate better participation in school by parents' participation.

Major activities are:

Capacity building of Parents/Caregivers to work with their children with disabilities.
Rehabilitation therapies for children with disabilities.
Facilitation of suitable assistive devices and adaptation required.
Developing support system for children with disability (mentors) at school
Sensitization of public, school management and government officials about Rights and needs of children with disability.



Three types of services are given in this program.

1. Home/school support program:

Where rehab professionals reach the child's home and or school to facilitate necessary therapeutic services. Also, we provide necessary special education support for the children that are studying in school. We mentor teachers to work with children with disabilities and also develop peer support through buddy system. We focus on maximum independence in self-care, communication and special education support for academic learning. Below is the domain wise achievement in children with disabilities.









Parents Managed Respite Center (PMRC)

It is a community participatory rehab centers for children with high support needs and managed by parents of children with disability. Amar Seva Sangam provide technical support as well as facilitate funding.



Vocational Training Centers (VTC)

This is community participatory vocational training center for Persons with intellectual disabilities to train them in a meaningful and productive work. Various skills like basket making, artificial jewels making, decorative, coconut shell products are prepared and currently sold at melas and at the center level

2.3 Village Based Rehabilitation – Development program

Under our community-based rehabilitation programs, we involve Persons with Disabilities (PwD) and the community in the rehabilitation process and develop a model whereby they own the responsibilities of rehabilitation, economic development and care giving and take forward the initiatives of the facilitating organization. Vibrant and proactive differently abled groups have been developed and parents' associations' have been formed. As on date, seven Respite Centers have been formed for lifelong care giving for the severely and permanently persons with disabilities. The main objectives of the community-based rehabilitation services are:

- > Sensitizing the community, families and persons with disabilities about disabilities.
- Mobilizing People with Disabilities into Self Help Groups.
- Promoting the Self-Help Groups for development and forming Federations wider level networking.
- Initiating comprehensive rehabilitation measures.
- Enabling the PWDs to access various government schemes.
- > Promoting advocacy work and campaigning for the protection of rights and equal opportunities for PWDs.
- > Strengthening human resources for the effective implementation of the process.



The entire activity is managed through periodical co-ordination meetings, planning, budgeting and internally developed reporting systems. Key indicators developed for impact and activity levels are monitored through system of computerized managerial information. Databases have been created for various rehabilitation programs and individualized rehabilitation programs are followed up by the central resource personnel of Amar Seva Sangam and course corrections done wherever required. Vibrant and proactive differently abled groups have been developed and parents' associations have been formed. As on date, 8 respite centers have been formed for lifelong care for children with high support needs and 785 Self Help Groups (SHGs) are functioning. Under our VBRI we cater to the needs of persons with disabilities persons in 8 blocks of Tirunelveli/ Tenkasi districts covering nearly 900villages with a population of 8 lakhs.

SUCCESS STORIES:

CASE HISTORY: 1

Mr. M. Dineshbabu s/o Madasamy he is 23 years old affected with mental illness for the past 3 years. He lives in S.V. Karai, Shencottah block. His father passed away due to cardiac arrest and he has a sister. He has grown up with his mother's care. He did not go for any job and spent full time idly and slowly picked up smoking habit with his friends group. He became addicted with smoking and liquor consumption.

Promoting Membership: Our field staff visited this case during on-field work. His mother requested our help to recover her son from mental illness. Our staff referred him to the self-help group for support through medicines and counselling. He has been a member of SHG for six months. His mother appealed for motivating her son during one the SHG's meetings and he was referred to Home Appliances Course in our Sangam.



Impact of Membership: He had taken training for home appliances course in Sangam and completed it successfully. He is employed in a private company in Surandai and he is a changed person now.

CASE HISTORY: 2

Ms. Selvasundari w/o Arumugam is 52 years old hardworking persons affected with polio and she has been the leader of SHG for PwDs for over 9 years. She lives in Alagapuri on Keelapavur block with her husband and two children. Both of them are working in the same company, earning Rs.15,000 per month. This income is not sufficient for the family. Our field staff identified her abilities and referred for Gold Appraisal course in our Campus.

Impact History:

She joined the gold appraisal course in Sangam and did well during the training. With her husband's support she started a gold finance shop and is now earning Rs.1,000 per day and leading a joyful life. She glorified Amar Seva Sangam for this guidance and help.



CASE STUDY: 3

Beneficiary / Name : M.Muthu

Age: 34/F / Disability type: LD/70% / Marital status: Single

Father name: Madakan (late) / Mother name / Age: Vellaiammal /70
Type of training: Tailoring / Place: Vargunaramapuram, Surandai

Case History: She is 34 years old and affected with loco motor disability with 70%. She did not pursue her school education as she was not interested in studies and also due to lack of transportation. She lost her father when she was 17 years old and the family became economically weak. She started rolling beedies for livelihood. Now, through Ventrikarangal Differently Abled SHG, she is receiving part benefits.



Promoting Membership: She is a member of self-help groups from on 2017. She did not receive any government grants/schemes. We helped her get pension for PwDs. As she engaged in beedi rolling, her health was affected. During our SHG meeting, our staff recommended to learn tailoring, which she learned with good interest.

Impact of Membership: She completed the tailoring course in February 2020. She is earning Rs.250/- per jacket stitching and leading a satisfactory life.

We have also developed mVBRI a web-mobile based cloud application in the "Salesforce" platform with the technical support from "Durvah IT Consulting Pvt. Ltd"Bangalore for our Early Intervention and Village Based Rehabilitation and Development activities. Our MIS team provides Design, Development, Implementation, Maintenance and Support Services to ensure Information System Securities and Optimum Utilization of Information Technology Resources.

4.1.3. Performance Appraisal

ASSA has a three-tier module of Performance appraisal in vogue. Every employee is given targets for deliverables at the beginning of the year with a timeline and at the end of the year same is assessed. After Self appraisal by the employees and reviewed by the section heads, the main appraisal as an interview with the concerned employee by a Committee of Executive Committee members headed by Secretary is completed and the result is given to the employee. Based on the result, annual increments are decided on a scale. This appraisal system helps the employees to interact well with the senior Management and understand their strengths and weaknesses. Necessary counseling and training are organized for the employees during the next year.

5. Exchange Program

Handi-Care Intl., a registered Canadian charitable organization, started Clinical Placements program for Canadian graduate students since 2006. HCI coordinates such placements for Canadian Physiotherapist, Occupational therapist and Speech language pathology students in their final year of masters program. HCI has facilitated accreditations from 11 universities from Canada and USA with Amar Seva Sangam to participate in the student's clinical placements. A major feature of this program is the overseas students earn a credit towards their degree from their respective universities. Additionally, professional volunteers from abroad render their services to supervise the students and give evaluations.



In the 2019 – 2020 period 11 professional volunteers rendered their services. Apart from supervising, the volunteers participated actively in creating training materials, providing training to our rehab staff and coordinating with our research initiatives in the Early Intervention and other Rehab projects. They shared advanced technical knowledge with us that are being implemented.

7. Donation and Fund Raising

7.1. Handi-Care Intl., Canada

Handi-Care Intl, Canada, headed by Smt. Sulochana Krishnamoorthy has been a pillar of strength. The funds collected by them are used for a wide variety of activities of the Sangam. Starting from a donation of Rs.6 lakhs in 1992, it has been gradually increasing year by year and during the year 2019-20 they have raised an amount of Rs.123.96 lakhs for ASSA. The total contributions up to March 31, 2020, was Rs.9.22 Crores. This includes yearly sponsorships of children/students and clinical placements from Canada.

We thank Mrs. Sulochana Krishnamurthy, President, Handicare Int'l, Canada, and her family and all the members and patrons of Handi-Care Intl., for their untiring efforts in mobilizing funds for Amar Seva Sangam over the past 28 years that has resulted 2,548 children actively enrolled in these programs and 688 children have been successfully discharged since 2017. The majority of these children are now enrolled in regular or special schools, allowing their families to work and earn a living.

7.2. Mr. Kalraman, USA

Mr. Kalraman, USA is one of the big supporters of Amar Seva Sangam. So far he has donated Rs.6,58,14,236 which includes about Rs.1,00,00,000 for the year 2019-20. The fund is utilized for the VBRI-Rehab Above 6 years program in 8 blocks of Tirunelveli District. This program reaches about 771 children and adults with Disabilities between 7yers to 25 years directly and by sensitization program and capacity building training we are reaching about 3,000 PwDs, their family members and other stake holders in the community. Through this funding we are able to organize all the needful services for this age group. They are,

- · Vocational training for adults with intellectual disabilities.
- Teaching Learning Materials, calipers and other assistive devices required for the children that are covered under this program.
- · Leisure activities for children with disabilities.
- · Exposure visits for children with disabilities and their parents.
- · Development of assessment tools and monitoring system of the program.
- Formation of Parents' Association towards advocacy.
- · Staff training and capacity building for human resource development in the field of disability.
- **7.3.** Oracle, USA is supporting Amar Seva Sangam through Charities Aid Foundation, New Delhi for our Project: Skill Development, Vocational Training and Rehabilitation for persons with Acute Spinal Injury and Physical and Mental disabilities. They have supported us with Rs.51,29,728 lakhs for the year 2019-20. This has benefited more than 298 service users to get training and empower themselves.



It is gratifying to note that while the number of donors has decreased by 7%, but the value of the donation has increased very significantly by 9.7% in the year 2019-20. 81% of our donors are from Tamil Nadu contributing 40% of our donations. Also while the per capita donations of a foreign donor is very high, their share in total donation is 26%. It is also interesting to note that they constitute only 1% in terms of numbers. 


Majority of our donors are in below Rs.5000/- range. While they constitute 51% of our donor base, they contributed 2% of our total donations. 46% of our donors are between Rs.5000/- to Rs.1 lakh. They contributed 17% of our donations. 81% of our donations had come from High Value Donors of above Rs.1 lakh who constitute 3% of our donors. 




8.2. Organizational Chart





8.3. Control Process Chart





Notes to Accounts

1. Significant Accounting policies

a) Trust Overview:

Amar Seva Sangam was established in the year 1981 as a Charitable Trust registered under Tamilnadu Societies Registration Act, 1975 vide certificate no TSI 16/1981 a model center catering to all the needs of the differently abled.

b) Basis of preparation of financial statements :

The financial statements have been prepared and presented under the historical cost convention on the accrual basis of accounting and comply with the Accounting Standards issued by the Institute of Chartered Accountants of India to the extent applicable. The financial statements are presented in Indian rupees.

c) Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent liabilities on the date of the financial statements. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods.

d) Fixed assets and depreciation

Fixed assets are carried at cost of acquisition less accumulated depreciation. The cost of fixed assets includes freight, duties, taxes and other incidental expenses relating to acquisition. Depreciation is provided on the written down method as per the provisions of Income tax Act 1961.

e) Inventories

Inventories are carried at the lower of cost and net realizable value.

Cost comprises purchase price and all incidental expenses incurred in bringing the inventory to its present location and condition. The method of determination of cost is as follows:

- * Finished goods at cost of production based on direct costing /landed cost on a first in first out method
- * Stores and spares at landed cost on a first in first out method

f) Retirement benefits:

Contributions payable to the recognized provident fund, which is a defined contribution scheme, are charged to the profit and loss account. Employee benefits on account of Gratuity with defined contribution plan covered under group gratuity policy with Life Insurance Corporation of India. Based on the quotation given by LIC, liability is created in the books. For leave encashment costs, which are not under defined benefit schemes, no provision accrued in the books and the same is discharged on a cash basis.

g) Revenue recognition:

Donations are accounted on a cash basis. Earmarked and specific donations are accounted appropriately in the books and the same is utilized for the purpose for which it is received. The funds received on account of non-earmarked/general will be used as per the discretion of the Trustees.

Donation amount received for specific projects are recognized on time basis.

Interest on deployment of surplus funds is recognized using the time proportionate method based on underlying interest rates and the same is taken to specific earmarked funds wherever mandated by the donor. In all other cases it is taken to revenue.



Interest Income recognized in the books separately and disclosed as Income separately for non- earmarked funds.

20% of Interest earned on corpus deposit (Other than projects) is added to corpus fund.

h) Foreign exchange transactions

Foreign currency transactions are recorded at the rates of exchange prevailing on the dates of the respective transaction.

i) Provisions and contingent liabilities

The Company recognizes a provision when there is a present obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation that the likelihood of outflow of resources is remote, no provision or disclosure is made.

Provisions for onerous contracts, i.e. contracts where the expected unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received under it, are recognized when it is probable that an outflow of resources embodying economic benefits will be required to settle a present obligation as a result of an obligating event, based on a reliable estimate of such obligation.

j) Investment

The Investments are recorded in the books at cost. Interest accrued but not due up to the date of balance sheet on deposit made under reinvestment plan are added with the deposits.

10. Outlook for the current year

Amar Seva Sangam's activities have earned a lot of appreciation and got wide attention among the national and international communities. Our initiative on Early Intervention (EI) has been widely acknowledged as a very innovative and cost effective program with high impact and this program needs to be brought into the focus of the stakeholders in various communities both in India and abroad. The EI program has received international recognition through the participation in Brazil and also in Dubai last year and also our specialist visited Canada for 3 months to spread the program and its effectiveness and also got training on the various new techniques that are now emerging not only in the field of EI but also in spinal injury and other areas of physiotherapy that will go a long way in bringing up the functional disabilities and make the person more capable.

In this context, the focus for the year 2020-21 will be:

- To get more representations to the national and international conferences and spread the success of the EI initiatives and build up partnerships for replications.
- The government, particularly the Tamil Nadu State Government, which has significant interest in promoting the EI to be
 roped in as partner to scale up to the immediate neighboring districts like Tuticorin and the remaining blocks in Tirunelveli
 to showcase the cost effectiveness and the success of the project and to later on establish the platform for a state-level
 program.
- To develop partnership with National Health Mission (NHM), particularly the Rural Health Mission where the El aspects have not reached the public at the grassroots level, to bring the concept of El and promote the model that we have developed.
- To bring in other state partners like SarvaSikshaAbyan into this, so that ASSA's application and the concept and technology that it has developed are complimented to penetrate the rural public in 0 6 age group, particularly in the age group of 3 6 where SarvaSikshaAbyan would be interested to expand and diversify
- The Central Government has established a separate Department for EI and has a separate Director in-charge of EI
 program under the Ministry of Social Justice & Empowerment. ASSA has already started the process of bringing the
 concept to the national level and the focus for the year will be to impress upon the central government to take up this
 project as a pilot in few parts of the country and later develop this into a larger project.
- To convene an international conference in February 2020 to bring in the experts and practitioners and government and non-government organizations across the world to share and discuss the EI experiences of their own and also share our experiences with them to maximize the potentials of children with developmental delays in their inclusion into the society.

Other Priorities for the current year are:

- The immediate expansion of Medical Testing Unit
- Joining hands with the Ministry of Skill Development and starting an ITI on a limited scale with the National Skill Development Council of India
- To improve the outcome and the reach of people undergoing training under Oracle project by linking with the national skill development program
- To initiate the process of setting up a Stroke Care Center has become a very important necessity, and which will have a high impact post-rehab outcome.
- To go forward with the expansion of the Spinal Injured Post-Acute Care Center from the existing capacity to additional 22-bed capacity.
- Improving the hygiene and standards of the Residential children by building fresh toilet facilities with accessibility and modern amenities.
- Improving the living conditions of Children in Residential Program For Special Needs Children by building proper hostel facility and removing the existing non eco friendly environment.
- Putting up the first phase of basketball stadium.
- · Complete the integration of Amar Seva Sangam activities through digitally monitored control systems.

Plans for the year 2020-21:

Covid relief:

- · Provide relief material for essential supplies to physically challenged to cover as many families as possible.
- Conduct covid awareness workshop to public on social distancing and sanitizing and mask.
- Covid compliant process for strict enforcement of movement of people within/ outside the campus.



Early Intervention Program with mVBRI App:

- We want to establish a separate social enterprise under Section 8 of Companies Act so that it becomes a leveraging
 entity to scale up our Early Intervention Program across not only in India but throughout the world.
- Our ambition is to reach out to at least 1,000 children with developmental delays outside of Sangam's area of operations
 through partnerships with NGOs in India and in other parts of the world. This will be in addition to the existing 8 blocks
 that the Sangam is working and the 23 more blocks that we will be adding during the year. This target will give
 enormous confidence to us in terms of the success of replication of our model and ability to package it into a sustainable
 business solution
- We have planned to have a robust Early Intervention program with license management system to manage the partnerships that will come along as we scale up, so that we are in a position to offer our model on a licensing basis that will be an income generation for our organization as well.
- In this connection, we would like to upgrade the app for 6 to 18 year group of children and also expand the functionality
 of the app to make it more family centered and also compliant with the international child functionality scales that are
 being promoted by WHO, before we roll out as a licensing model to others.
- On-board NGOs for m-EI app with full training and subsequent monitoring and control of EI program in least three States.
- Implement Tamil Nadu Govt. scale up program for Rehabilitation through Early Intervention to the children in three districts, viz., Tenkasi, Tirunelveli and Tuticorin.
- Help establish and manage Tenkasi district Early Intervention Center for Children with Developmental Delays.

Capital Expenditure Projects:

- · Complete Foster Care Center for Intellectually Challenged.
- Our objective is to complete the toilet block for the Home children as well as the compound wall during 2020-21. We
 also would like to complete the Foster Care Center and the RPSNC building during this period.
- We would like to complete the renovation and repair works of Post-Acute Care Center for the Spinal Injured as well as
 complete the extension work and inaugurate the Medical Testing Unit that is in the final stages of completion, during
 the year.
- Complete renovation of building for Residential Program for Special Needs Children.
- · Development of Rehab Orchards with new plants, flowers, flora and fruits.
- Compound wall construction in two phases in the East to Northern side of campus.

Fundraising as backbone

We need to strengthen the fundraising mechanism in the organization by building a good capable team with professional guidance of experts in this field in the coming years. Social media and digital platforms have opened up plenty of opportunities for reaching out to donors and mobilizing funds. In addition, the funding through Corporate Social Responsibility could be channeled to Amar Seva Sangam to fund our major program and initiatives. Further, tapping of crowd donors who may be giving small amounts but at regular Intervals and in large numbers, would strengthen the backbone of Amar Seva Sangam'sdonor base. The digital payments have eased the way of donating and Amar Seva Sangam should be able benefit out of this to bring in large number of retail donors and make it a strong donation-based organization,

In the years to come, in addition to various other sustainability measures that the organization is taking, the sustained growth of Amar Seva Sangam would greatly depend on how much we have professionalized our fund raising methods, techniques and practices. Investment in this front is imperative to achieve this.

Amar Seva Sangam as Center of Excellence

Approaching large funding organizations, both national and international, is critical for the aspirations of the organization in terms of developing innovative solutions and sustainable models for persons with disabilities for their rehabilitation as well as inclusion in the society. The recognition of sustainability can be seen by the fact that the United Nations has embarked upon 17 Sustainable Developmental Goals that need to be achieved Globally by 2030. For an organization like Amar Seva Sangam, we need to have talented professionalized team to create ideas from vision, develop concepts, make it into an incubator project, and come out with a prototype of successful model; or if not emerge with abundance of knowledge arising out of the learnings. This knowledge capital will be the strength of this organization and our valuation will run high among the prospective funders. The aim should be to become a center of excellence in the field of disability management, its techniques, processes, and the use of technology.
