The Certificate of Registration is awarded to “Amar Seva Sangam- Community Based Rehabilitation”, located at No.10/2/170, Sulochana Garden, Tenkasi Road, Ayikudi Town Panchayat, Kadayanallur Taluk, Tenkasi - 627852, as an Institution for the persons with disabilities vide **Reg.No.243/2026**, under section 51 (2) of the RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 (Central Act 49 of 2016) to run a **Community Based Rehabilitation Programme – CBR**. This certificate of registration is valid from **01.03.2026 to 28.02.2028** and is subject to the following conditions:-

Application for granting renewal of a certificate of registration should be submitted to this office two months in advance before the expiry of the period of validity.

1. The Management should not appoint any staffs whose Certificate has been cancelled or who have been convicted for offence involving moral turpitude.
2. The State Government grant will not be given at present.
3. The Institution should provide proper barrier free accessible environment & infrastructure facilities including sufficient accommodation to the persons with disabilities.
4. This certificate should be displayed by the institution in a conspicuous place.
5. The following words may be mentioned in the name board of the Institution to “Amar Seva Sangam- Community Based Rehabilitation”, located at

No.10/2/170, Sulochana Garden, Tenkasi Road, Ayikudi Town Panchayat, Kadayanallur Taluk, Tenkasi - 627852, is registered under Section 51(2) of the Rights of Persons with Disabilities Act, 2016.

6. Institution should follow rules/regulations issued by Director for Welfare of the Differently Abled from time to time.
7. The Institution is subjected to inspection by the inspection authorities under the Act/Rules and by the persons / officers authorized by the State Government.
8. The certificate of registration is liable to be revoked as per the provisions given in the section 52 of the Rights of Persons with Disabilities Act, 2016.

The registration shall be subjected to the conditions laid down in the **RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016**. The Institution should comply with Rules/Regulations/Instructions issued by Director for Welfare of the Differently Abled from time to time.
